U. S. Senator Thomas J. Dodd, arch proponent of the cold war and notorious opponent of East-West accommodation, continues to press his attack on the Pugwash scientists.

As you will see from the enclosed Congressional Record item, arrangements have been made for the printing at Government expense of an additional 6,000 copies of Senator Dodd's so-called study of "The Pugwash Conferences," which was originally issued and released widely to the press on May 28,1961. Dodd is Vice Chairman of the Senate Judiciary Subcommittee on Internal Security.

The 139-page Dodd study presents a distinctly misleading picture of the Conferences. Typical of its many inaccuracies is the insinuation that all those associated with the Conferences are either Communist dupes or part of the Communist conspiracy.

Senator Dodd recently sent his Pugwash study to all newspapers in Canada and to all Canadian Senators and Members of Parliament. Mailings such as this are made at Government expense.

Unless and until those associated with the Pugwash and succeeding COSWA meetings take issue, you will realize that the Dodd study will continue to be accepted as fair and factual in uninformed circles in many parts of the world.
